- 2. Hear an update from the RPBC Chair.
- 3. Confirm Appointments to the BCCC by the RPBC Chairman.
- 4. Approve the Agenda for the Central Committee Meeting
- 5. Approve the Special Rules for the Central Committee Meeting
- 6. Elect a Temporary Chair, Vice Chair, and Secretary for the County Quadrennial Convention.
- 7. Temporary Recess for Ward Caucus Meetings (if needed).

#### NOTE:

The purpose of the County Quadrennial Convention is to elect 249 Delegates to the State Quadrennial Convention. These Delegates will have voting privileges at the State Quadrennial Convention and will elect Representatives to the RNC National Convention.

## **Special Rules proposed for this County Central Committee Meeting are:**

- 1. Proxies: any BCCC Member in attendance may carry only one (1) proxy for another member of their Ward, per USR 3-1-3C.
- 2. The voting process will be by a show of index cards included with each name badge.
- 3. Any Republican who is not a member of the BCCC is welcome to attend.
- 4. Voting is limited to BCCC members only who are current on their membership fee as of March 20, 2024.
- 5. Pre-registration is required. **Registration closes at 5:00 pm MDT, Wednesday, March 20th, 2024**. There will be no registration at the door. There will be no exceptions to or exemptions from the pre-registration requirement.
- 6. RPBC and the County Central Committee follow Robert's Rules of Order and the appropriate decorum expected and required. Free speech requires good order, so all are heard.

7. Any questions or additions to the agenda for this meeting shall be presented to the County Secretary (secretary@rpbc.gop) by March 11th, 2024, at 5:00 pm.

## Special Rules proposed for the County Quadrennial Convention are:

- 1. Any Republican interested in serving as a Delegate to the State Quadrennial Convention must **self-nominate** and meet the requirements no later than March 20th, 2024, at 5:00 pm, using the form in the link below.
- 2. Delegates that are elected to attend the State Quadrennial Convention shall be responsible for all required fees and expenses for attendance to the Convention to be held on April 27th, 2024, and if elected, for fees and expenses to attend the RNC Convention in Milwaukee, Wisconsin, July 15-18, 2024. (Estimated cost of attendance to the RNC Convention is \$4000-\$5000.)
- 3. 249 Delegates will be elected from the pool of self-nominations. If there are more than 249 self-nominations, Ward Caucuses will be convened, and delegates will be elected by each ward. If there are fewer than 249 self-nominations, delegates will be elected in the main Quadrennial Convention meeting.
- 4. No proxies will be allowed.

## **Special Rules proposed for the Ward Caucus Meetings are (if needed):**

- 1. Any Registered Republican is welcome to attend the meeting and are allowed to vote.
- 2. Pre-registration is required. **Registration closes at 5:00 pm MDT, Wednesday, March 20th, 2024.** There will be no registration at the door. There will be no exceptions to or exemptions from the pre-registration requirement.
- 3. Ward Officers will conduct the Ward Caucus Meeting for their respective Ward.
- 4. No proxies will be allowed for the Ward Caucus meeting.
